Overview

During the 84th Texas Legislative Session, House Bill 1842 was passed providing public school district the opportunity to seek a District of Innovation (DOI) designation. The designation allows eligible districts to exempt certain provisions of the Texas Education Code (TEC) in an effort to create additional local flexibility in the district planning and decision-making process. The term of the District of Innovation designation may not exceed five years. On *February 13, 2017*, the Banquete Independent School District's Board of Trustees adopted a resolution initiating the process of becoming a District of Innovation.

Board Resolution

RESOLUTION TO ADOPT A DISTRICT OF INNOVATION

WHEREAS Education Code 12A.001 provides that a district is eligible for designation as a district of innovation if the district's most recent performance rating under Section 39.054 reflects at least acceptable performance, and that consideration of designation as a district of innovation may be initiated by a resolution adopted by the board of trustees of the district; and

Term

As outlined by the Texas Education Agency, the term of the innovation plan is five years. The plan will begin with the adoption of the 2017-2018 school year, Board of Trustees regular meeting and conclude at the end of the 2021-2022 school year., unless terminated or amended earlier by the Board of Trustees in accordance with the law. Banquete ISD will exercise the authority to exempt itself from the following state requirements for a five year period running through the conclusion of the 2021-2022 school year, including:

- □ School start window
- Required length of school day
- Teacher Certification

The District Improvement Committee in conjunction with the DOI Committee will monitor the effectiveness of the plan and recommend to the board modifications as needed.

District of Innovation Plan

 School Start Date BISD Board Policy EB(Legal) §25.0811

Current Law

State law currently prohibits school districts from starting class before the fourth Monday in August, unless they are year-round districts.

Proposed

BISD will start class no earlier than the third Monday in August, and will plan to end earlier in the spring semester in order to better balance the days in the fall and spring semesters, to provide more educational days prior to schedule state assessments, and to better align with dual-credit college courses in the Fall, Spring, and Summer semesters. The primary goals of this change is to create greater flexibility in the District's Calendar are to improve the overall district attendance rate, to improve student success on state and local assessments, and to allow for greater opportunity for meaningful staff development throughout the school year.

Length Of School Day BISD Board Policy EC(Legal) §25.081

Current Law

State law currently requires that all school days must be 420 minutes long each day in order to count for ADA calculations and funding purposes, and to accumulate instructional minutes towards the 75,600 minutes required annually.

Proposed

Exempting from the 420 minute day requirement would allow BISD the flexibility needed to alter the school day schedule on selected day's whenever it was locally determined as necessary or beneficial to the district and its stakeholders. While there is already a waiver process available to request exemption from this requirement, the waiver is limited to a 6-day maximum number for the school year. Exempting completely from the 420 minute requirement would give the district a significant amount of local control over scheduling (above and beyond the 6-day maximum as needed) without the fear of diminishing state funding or losing credit for instructional time that might cause the district to fall out of compliance with annual minute requirement.

BISD does not intend to shorten the school day on a regular basis, or without specific purpose. To the greatest extent possible, "early release" days would be planned ahead of time and noted in the district calendar, which is approved by the Board of Trustees and published/distributed to district stakeholders in advance of the school year. The district would not schedule early release days under this exemption that were shorter than 240 minutes (4 hours).

3. Teacher Certification BISD Board Policy DBA (Legal) §21.003

Current Law

State law currently under Title 1, Part A of the Elementary and Secondary Education Act (ESEA) (*20U.S.C. 6301 et seq.) notify the parents of each student attending any school receiving such funds that the parent may request, and the district shall provide the parents on request (and in a timely manner), information regarding the professional qualifications.

Proposed

Banquete ISD proposes to be able to assign a teacher with proper credential endorsement to a grade level other than teacher certificate specifications (IE. Math teacher with teaching certification 7-12 may teach a 6th grade Math class).
