CAC CONSENSUS WAS NO I&S TAX INCREASE

\$48,445,000 BOND (Estimate)

Investigative efforts and cost estimating will continue focused on items as prioritized above.





BANQUETE ISD TAX RATE COMPONENTS

M&O Tax Rate: \$0.78560

I&S Tax Rate: \$0.40846

Total Tax Rate: \$1.19406

I&S may not exceed \$0.50

M&O "Maintenance & Operations" Tax Rate

 Funds used to operate the school district such as salaries, utilities, equipment, supplies

I&S "Interest & Sinking" Tax Rate

- May only be used for the repayment of voter approved bonds by election
- Examples: construction, land, buses, technology, HVAC, roofing

CAC FORMAL RECOMMENDATION

THE RECOMMENDATION FROM BISD CAC IS SHOWN BELOW

After four (4) community stakeholder meetings, and reviewing the feedback provided during the process, the recommendation from the CAC to be considered is as follows:

The Banquete CAC formally recommends the district consider a NO I&S TAX RATE INCREASE bond election for May 4, 2024, in the amount of \$48,445,000 to address BISD facility needs, to include:

- 1. New Junior High School with Gym and Dining Hall
- 2. Reinvestment of HVAC, Plumbing, Electrical, Roofing as needed across BISD
- 3. Safety & Security Vestibules at Elementary & High School
- 4. Elementary Shade Structures & Playground Equipment
- 5. High School Expansion/Renovation (CTE)
- 6. Athletic Facility Upgrades
